DIRECTIONS

From Interstate 4: Exit 27 – Polk Parkway. Take Polk Parkway to first exit (Exit 3), 25-cent toll (EXACT CHANGE), right on Airport Road. Go 1 mile to 2nd traffic light, left on Drane Field Road, 4/10 mile to Century Boulevard, turn left (across from airport – Renna Enterprises on corner), left at 4th driveway into warehouse complex, go to back building. IPOC Dog Training sign on building.

From Highway 60 (Bartow): US 98 North to Polk Parkway West. Exit at Waring Road, left at the light, go under Parkway to 2nd traffic light. Turn right on Drane Field Road, go about 1 mile, turn right on Century Boulevard (Renna Enterprises on corner), left at 4th drive into warehouse complex, go to back building. IPOC Dog Training sign on building.

From Highway 60 (Brandon): Left (North) on County Line Road at the Polk/Hillsboro boundary between Mulberry and Plant City. About 5 miles, turn right on Drane Field Road, about 2 4/10 miles turn left on Century Boulevard (across from airport – Renna Enterprises on corner), left at 4th drive into warehouse complex, go to back building. IPOC Dog Training sign on building.

IMPORTANT INFORMATION

EXHIBITOR INFORMATION: These trials will be held indoors in an air-conditioned facility, fully matted and gated. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or the trial is cancelled because of storms, hurricanes, or conditions injurious to our exhibitors and spectators. **NO X-PENS.** No pinch collars allowed in the building. Due to space, no strollers of any kind are permitted. Please leave the grounds in the condition you found them. Dogs cannot be left in the building overnight, but you may leave your crates and chairs. No smoking allowed in the building. Children must be supervised at all times. Park in designated areas and please respect other tenants' space in the complex.

IMPORTANT: Dogs not in the ring must be on leash or crated at all times. Handlers are responsible for cleaning up after their dogs. There is a fenced potty area available. DO NOT potty your dog in any other area. Handlers in violation of this policy may be excused by the Trial Committee without benefit of refund.

Important things to remember:
